











#### Source-Drain Diode Forward Voltage





Single Pulse Power, Junction-to-Ambient

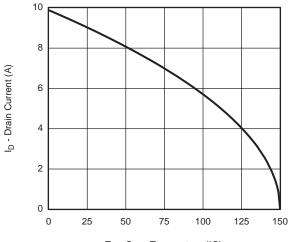








 $T_C$  - Case Temperature (°C)











