




Crimp Terminal Housings(30)




Quick Disconnects(15)

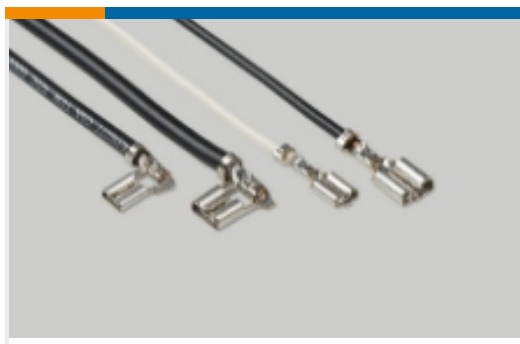

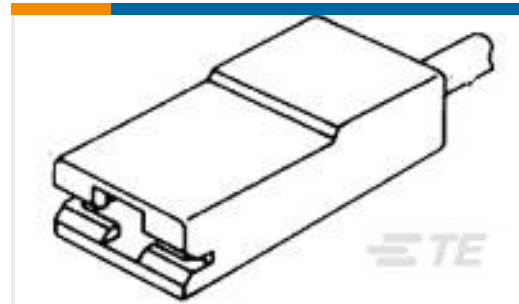
