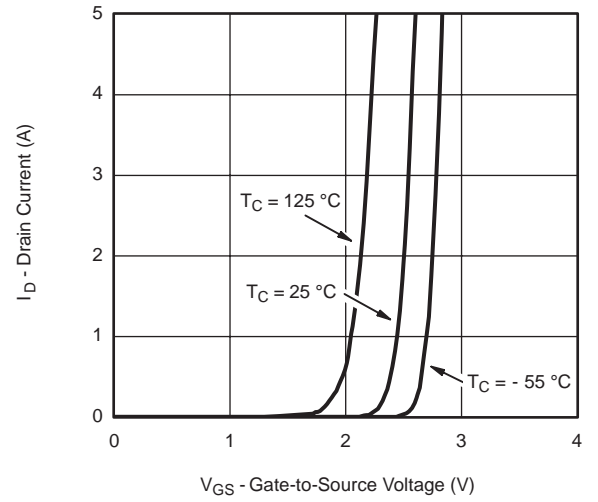

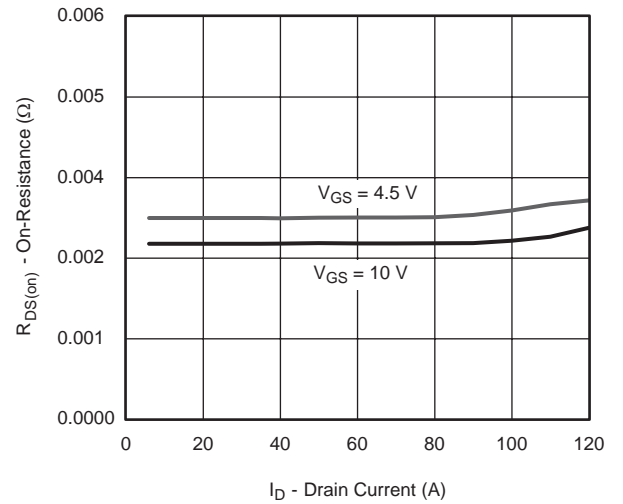

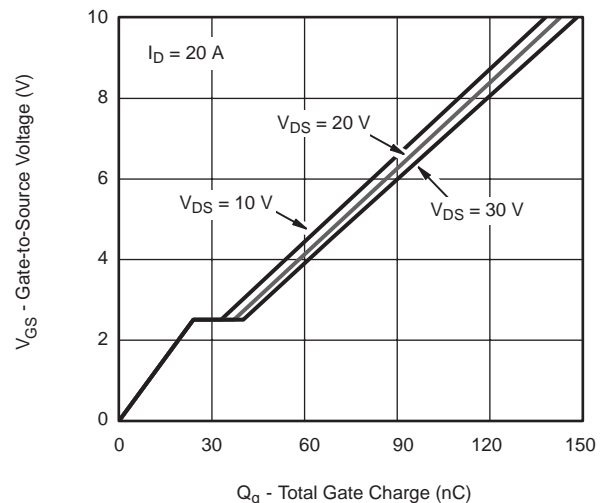

**On-Resistance vs. Drain Current**

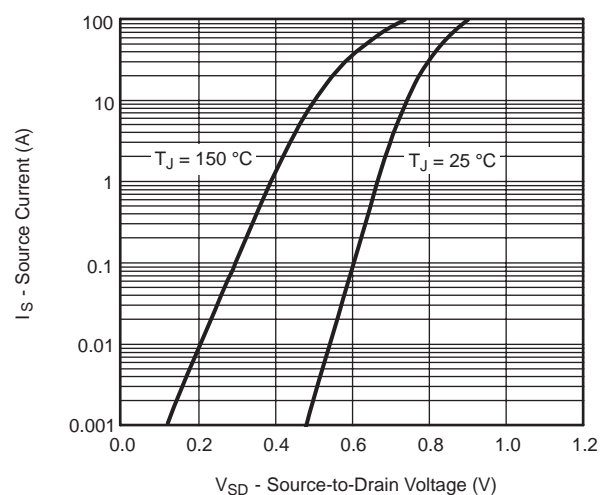

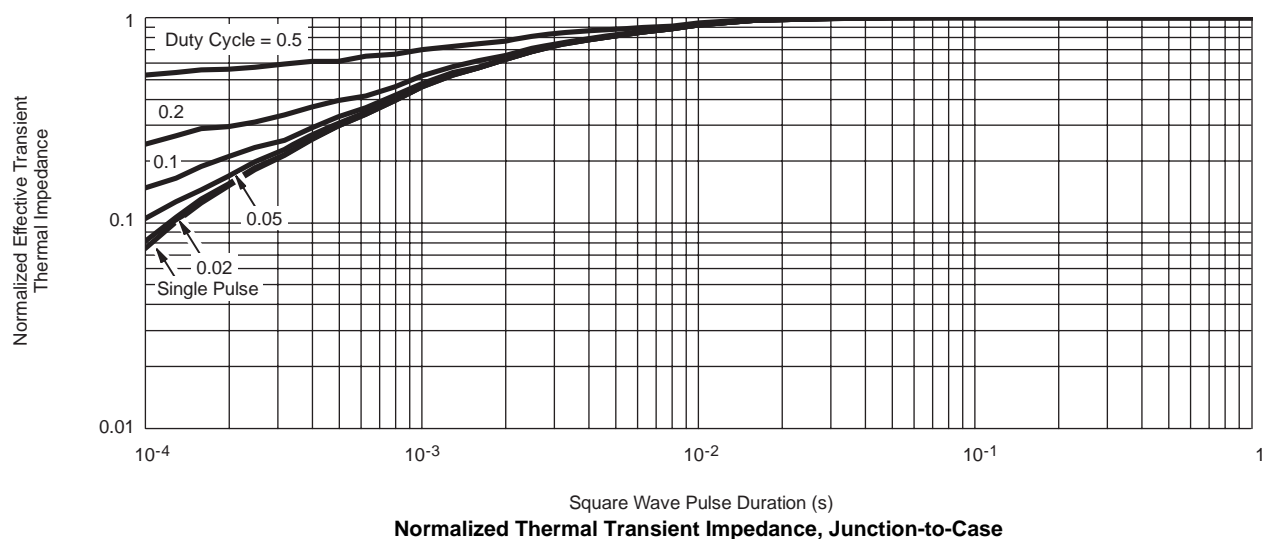
