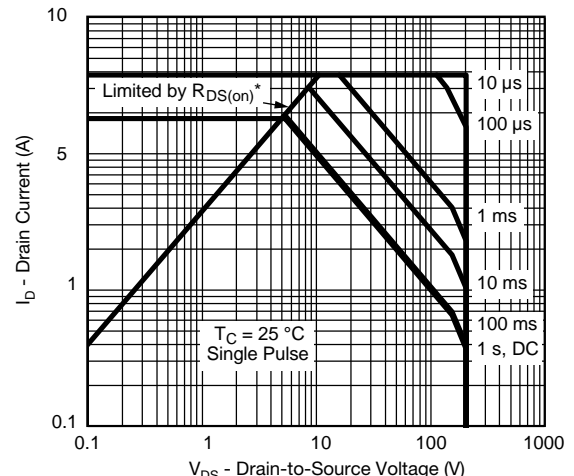

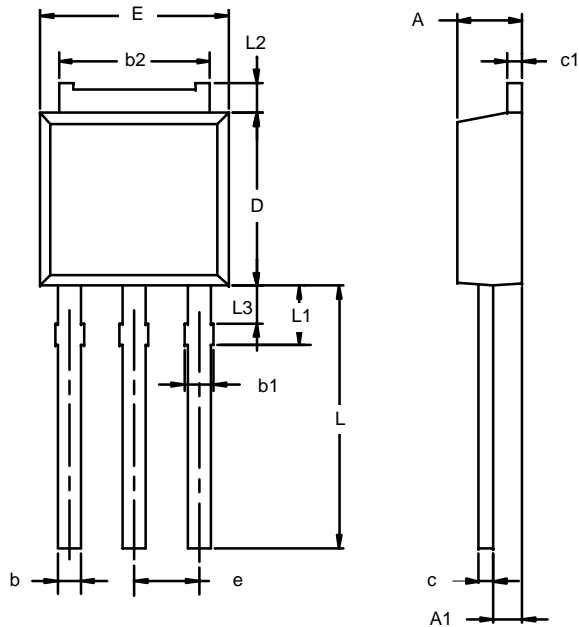
**Maximum Avalanche Drain Current
