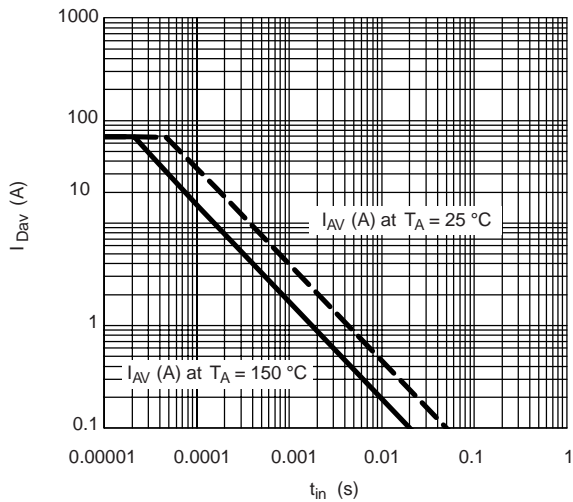

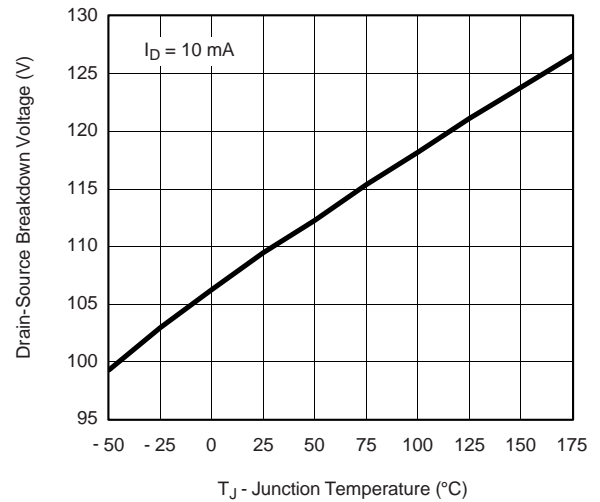
**On-Resistance vs. Junction Temperature**



**Source-Drain Diode Forward Voltage**

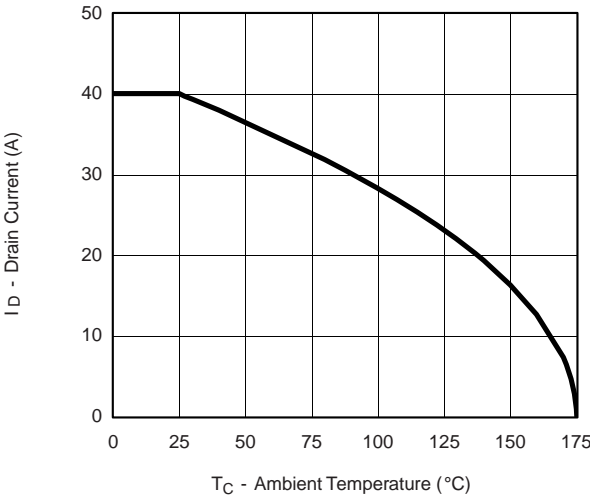


**Avalanche Current vs. Time**

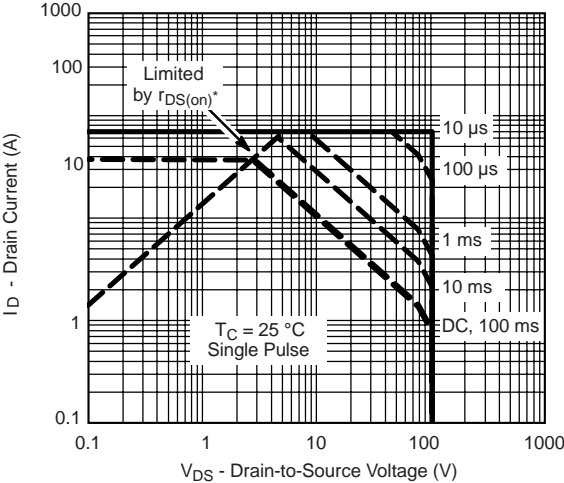


**Drain-Source Breakdown Voltage vs. Junction Temperature**

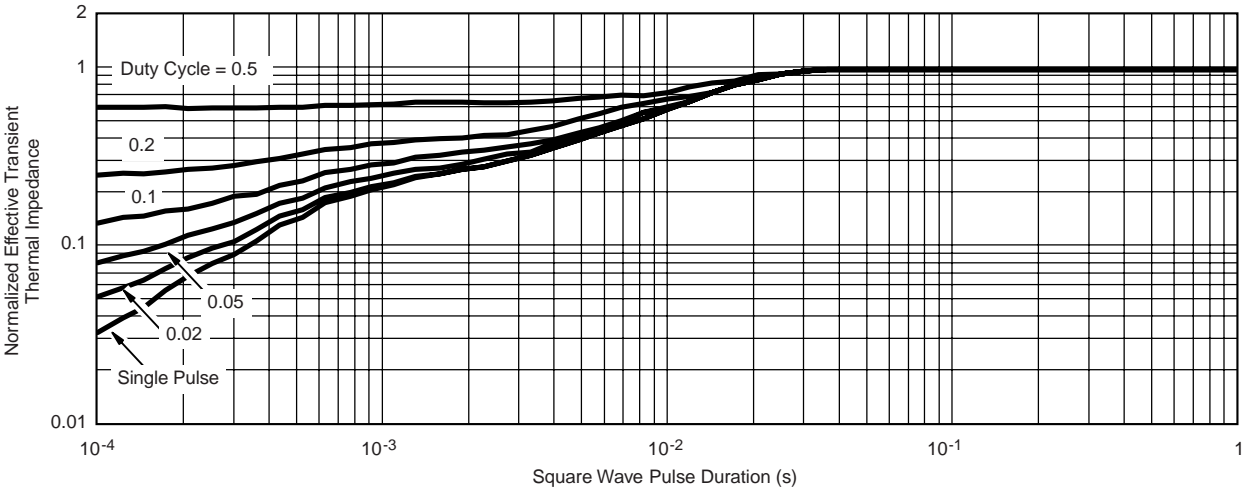

**Maximum Avalanche and Drain Current vs. Case Temperature**

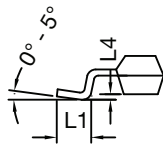
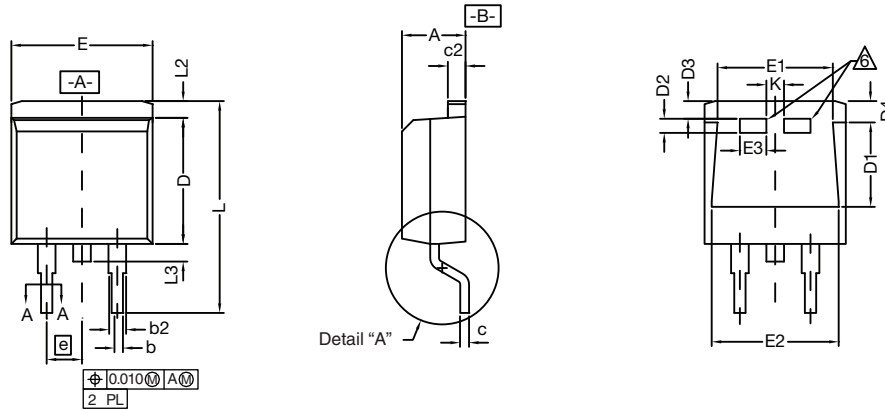

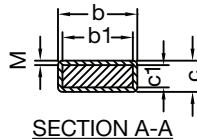


**Normalized Thermal Transient Impedance, Junction-to-Case**

DETAIL A (ROTATED 90°)

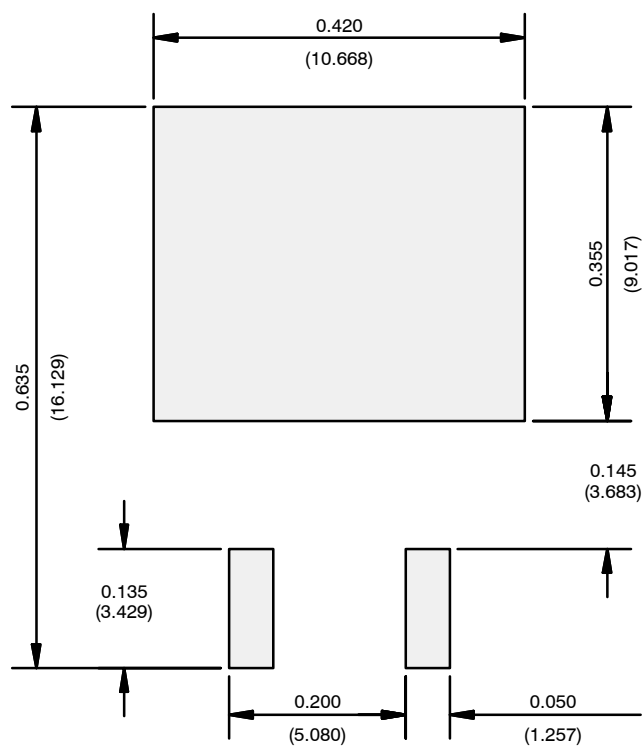
