





On-Resistance vs. Junction Temperature




 $\rm R_{\rm DS(on)}$ vs. $\rm V_{\rm GS}$ vs. Temperature

Threshold Voltage





Safe Operating Area, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Case


