


TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted








On-Resistance vs. Junction Temperature




 $V_{SD}\,$ - Source-to-Drain Voltage (V) **Source-Drain Diode Forward Voltage**





Drain Source Breakdown vs.
Junction Temperature








Normalized Thermal Transient Impedance, Junction-to-Case
