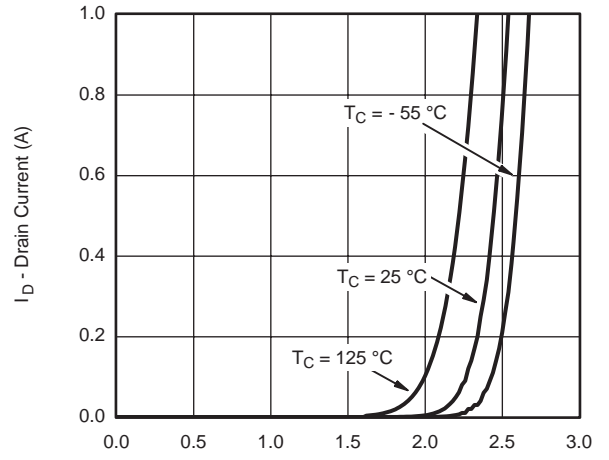

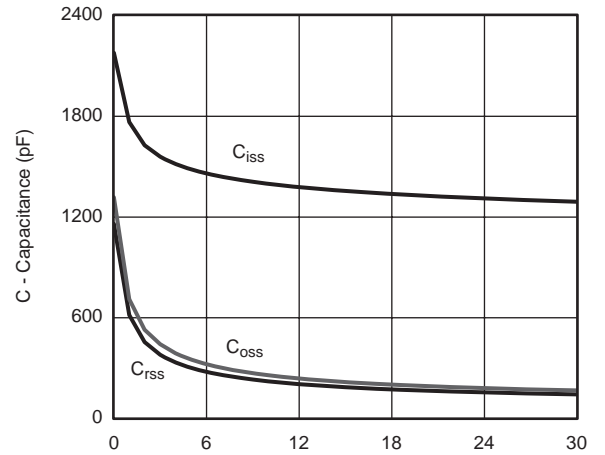
$V_{DS}$  - Drain-to-Source Voltage (V)

**Transfer Characteristics**



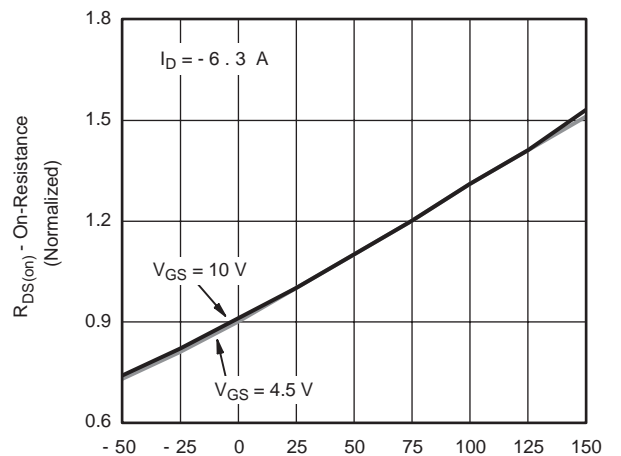
$I_D$  - Drain Current (A)

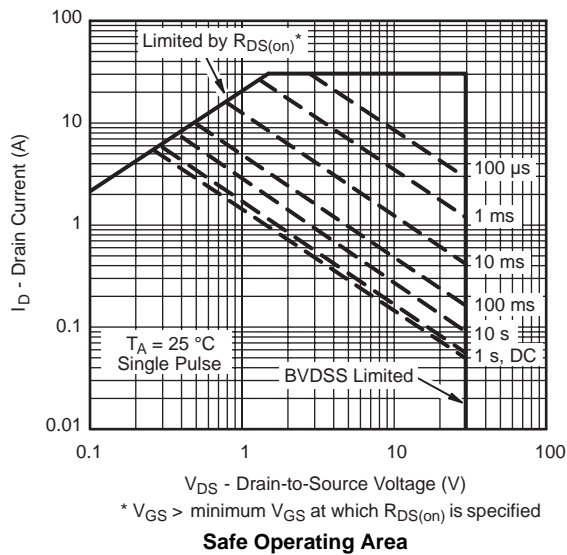
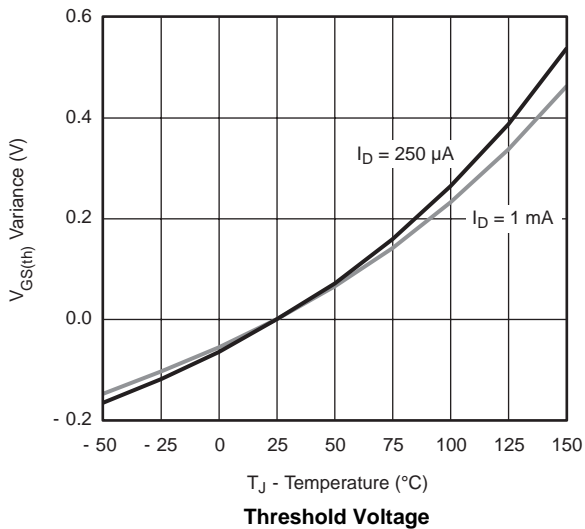


$Q_g$  - Total Gate Charge (nC)

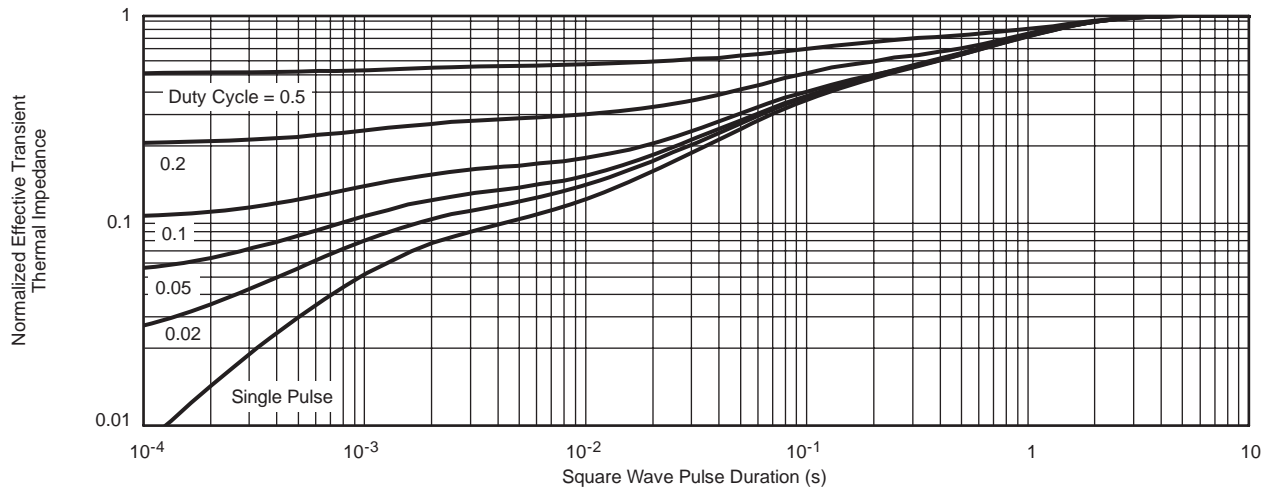

**Normalized Thermal Transient Impedance, Junction-to-Foot**

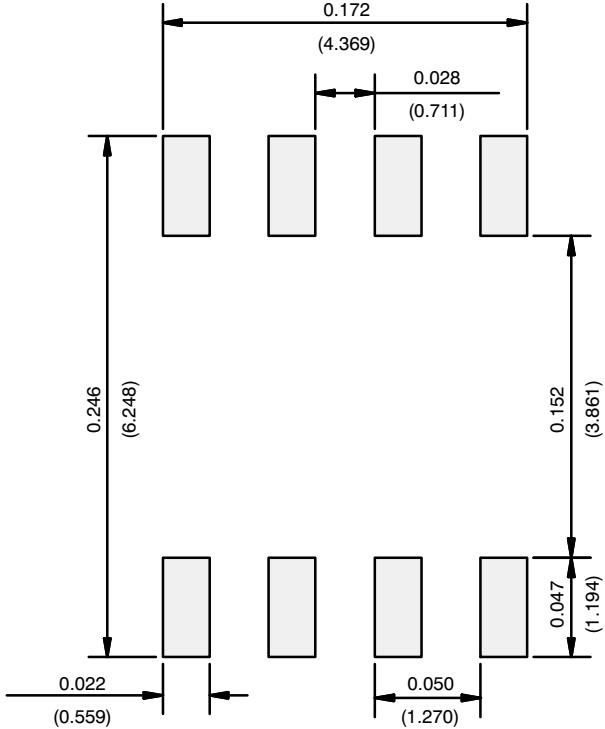
