







**On-Resistance vs. Junction Temperature** 



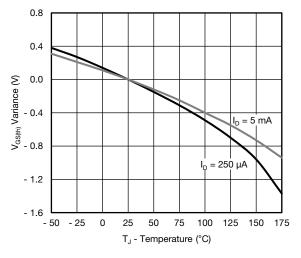
**On-Resistance vs. Gate-to-Source Voltage** 



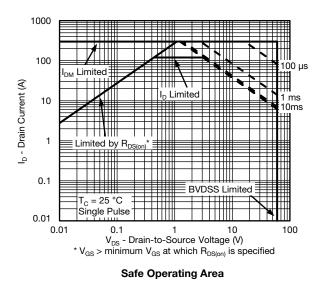
Drain Source Breakdown vs. Junction Temperature



Source Drain Diode Forward Voltage








