




#### Source-Drain Diode Forward Voltage




Threshold Voltage

Single Pulse Power, Junction-to-Ambient







#### MOSFET TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



 $T_{\mbox{\scriptsize C}}$  - Case Temperature (°C)









Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot


