









On-Resistance vs. Drain Current and Gate Voltage



 $V_{\text{GS}}$  - Gate-to-Source Voltage (V) **Transfer Characteristics** 




V<sub>DS</sub> - Drain-to-Source Voltage (V)




On-Resistance vs. Junction Temperature



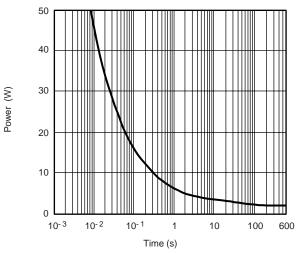




#### Source-Drain Diode Forward Voltage




On-Resistance vs. Gate-to-Source Voltage






Single Pulse Power, Junction-to-Ambient




Safe Operating Area, Junction-to-Ambient












