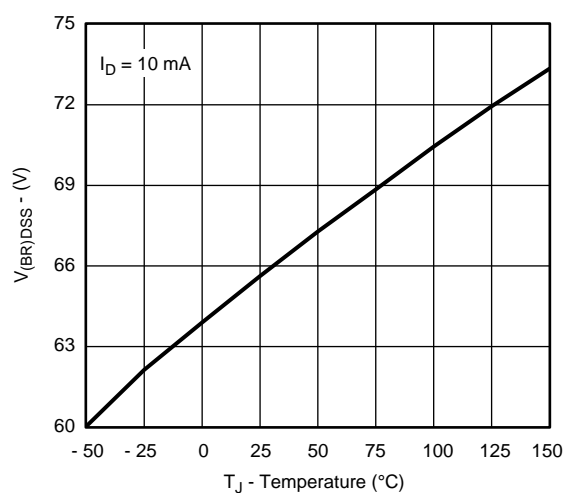
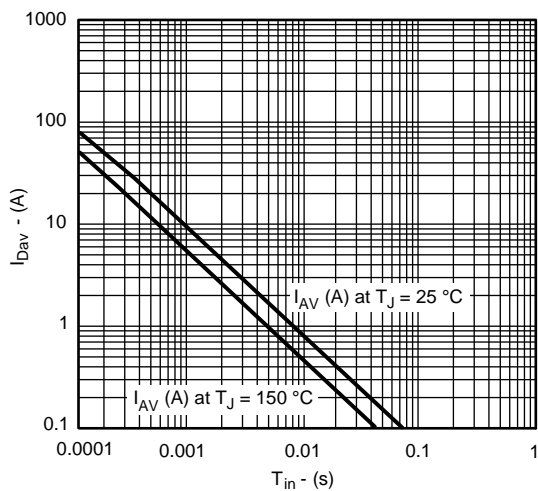
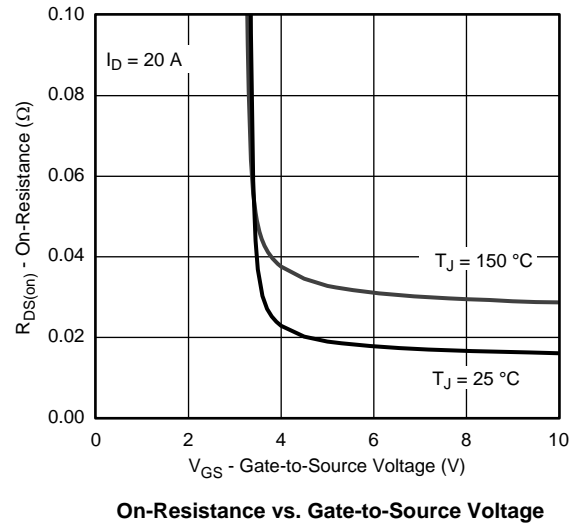
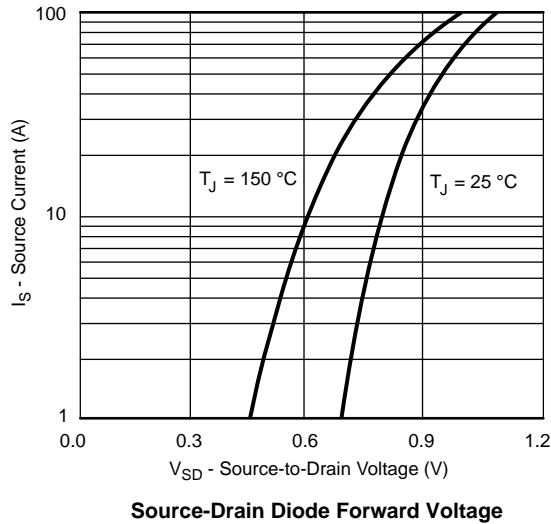
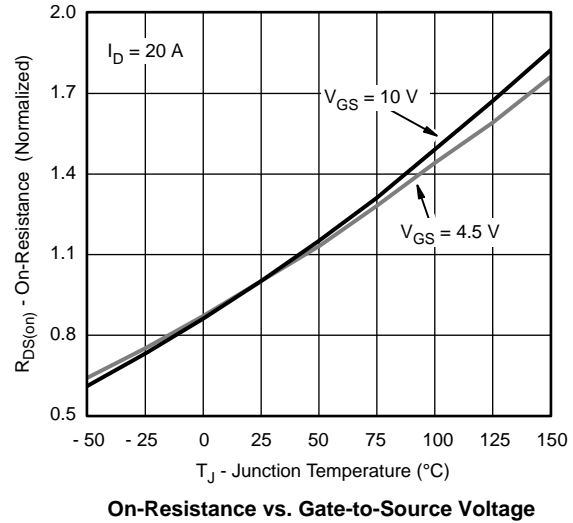
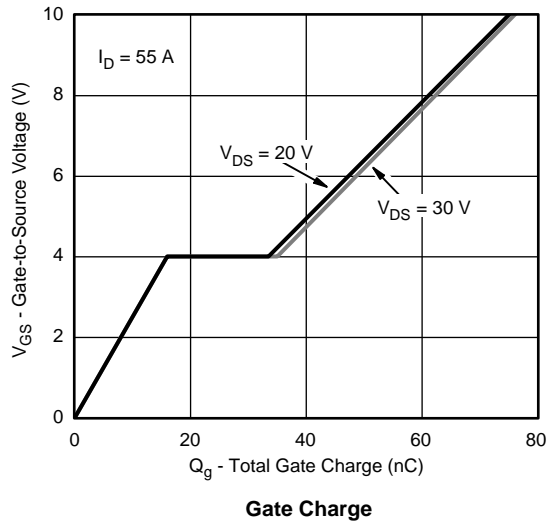


On-Resistance vs. Drain Current

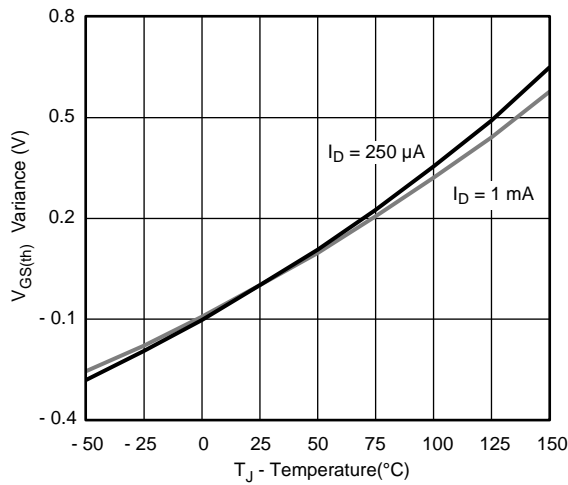

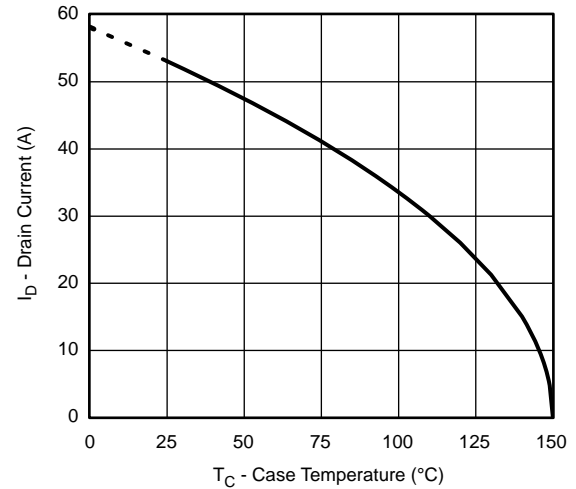

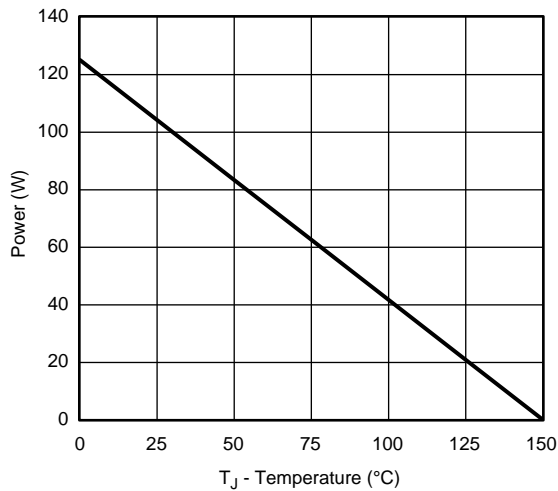

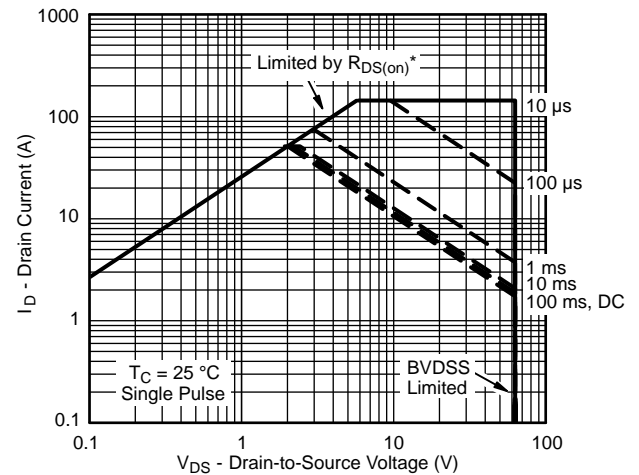
Threshold Voltage



Max. Drain Current vs. Case Temperature

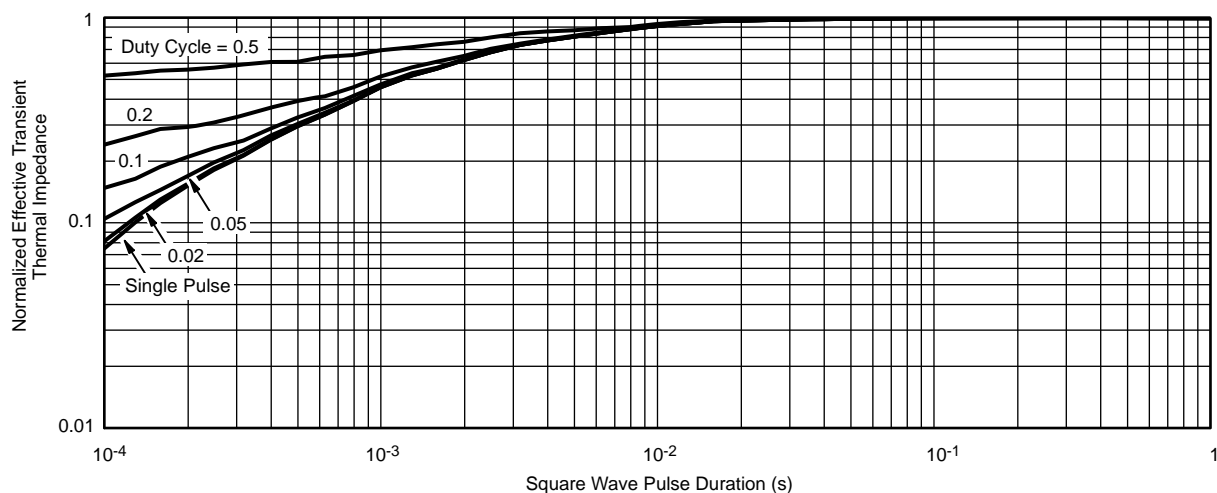


Power Derating, Junction-to-Case



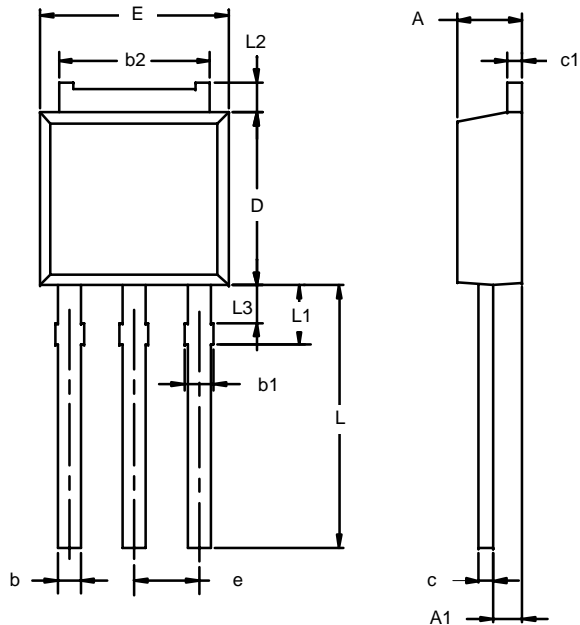
