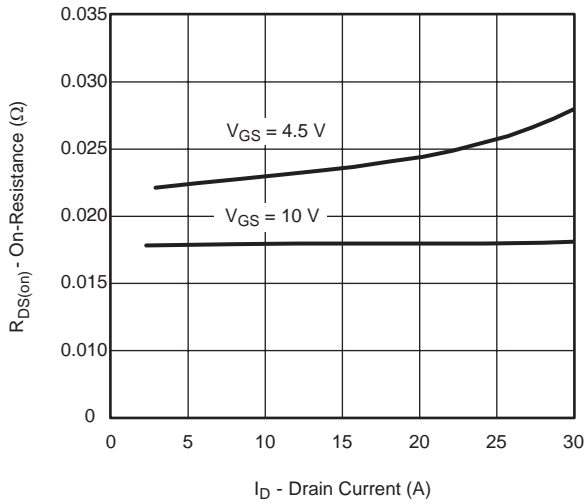

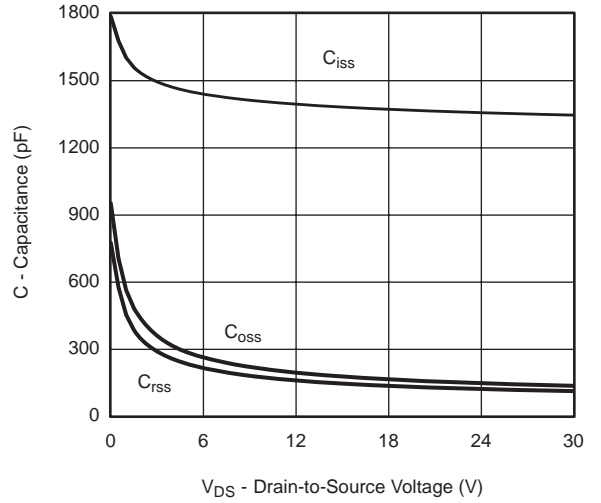

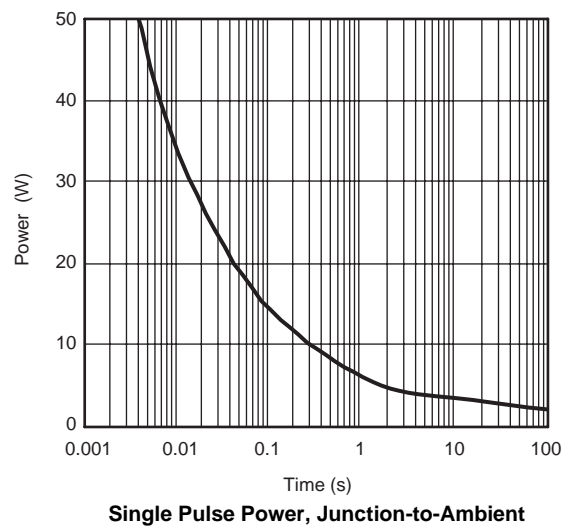
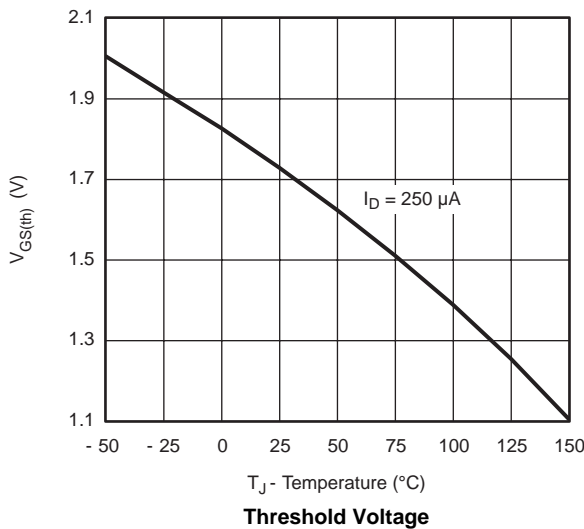
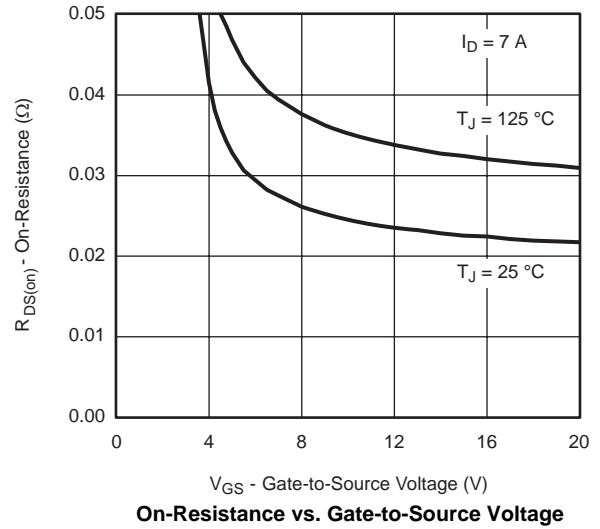


**Gate Charge**

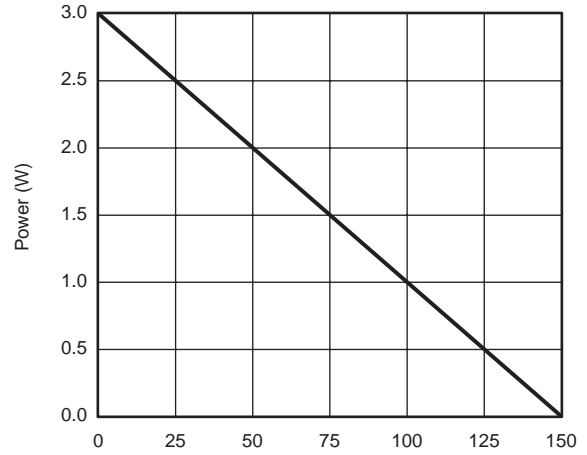

**Current Derating\***



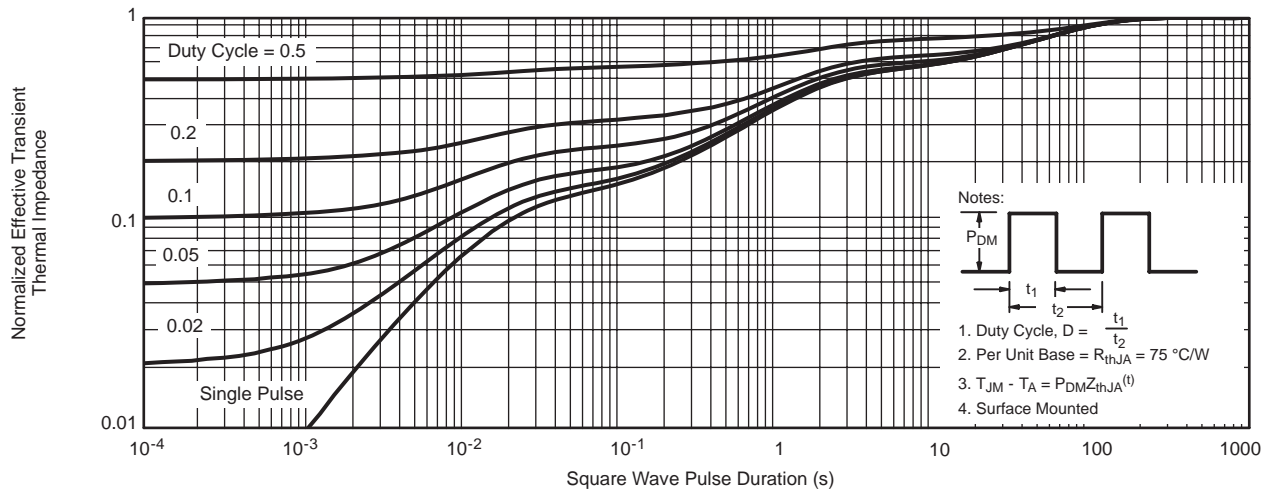
**Power, Junction-to-Foot**



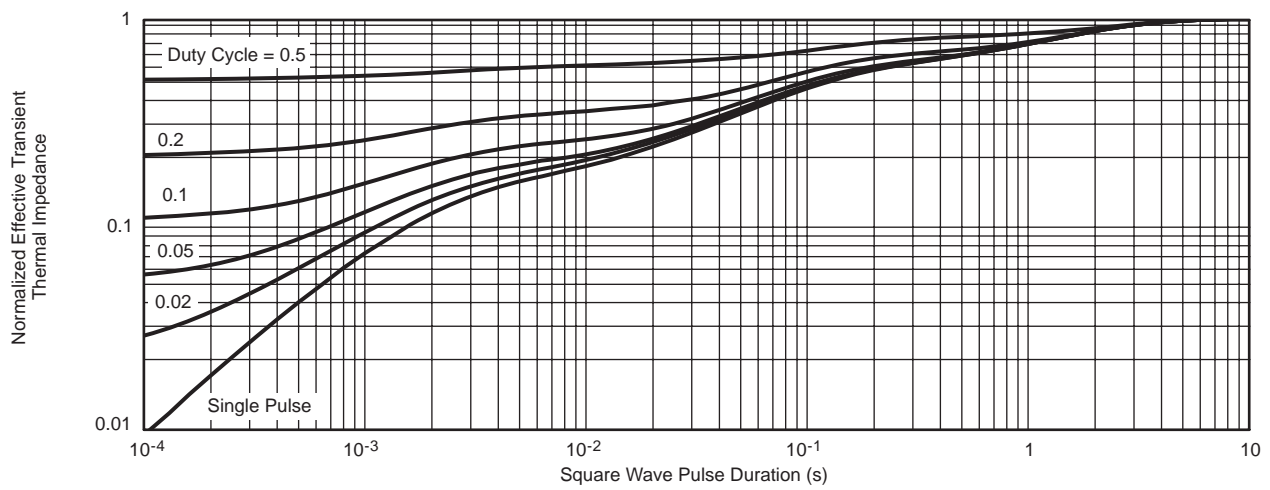
